This article covers how to cite in APA Style (7th ed.) when there are no known authors for a reference or when the author is unknown or cannot be reasonably determined. Before treating a reference as though it has no author, consider whether a group or organization (such as a government agency, association, nonprofit organization, business, hospital, task force, or study group) could be the author by checking the cover or title page. Citing in-text when there are no authors APA 7th ed. uses the author-date citation system for citing references in-text. In parenthetical citations, this structure includes the author's last name and the publication year (with a comma separating them) in parentheses. In narrative citations, the author's last name is incorporated into the sentence. This formatting applies if your source has one author or if you are citing a source with multiple authors in APA. Parenthetical citation for source with author: (Author Last Name, Year Published) (Cheung, 2013) Narrative citation for source with author: Author Last Name (Year Published) Cheung (2013) If a reference has an unknown author, the title of the work substitutes as the author name in the in-text citation. The title should have each significant word capitalized (basically sentence case). If the source is not italicized in the reference list entry, place the title in quotation marks (" ") in the in-text citation. If the source title is italicized in the reference list entry, italicize the title in the in-text citation (example: books when cited in APA). Alphabetizing the reference list for sources with no known author Reference list entries without an author are alphabetized by the first significant word of the title. Ignore the words "A," "An," and "The" when putting your reference list in order. Begin the entry with the word "Anonymous" only if the work is signed "Anonymous." If the reference has no author and is not signed "Anonymous," then you can alphabetize it in the reference list based on the work's title. If the title begins with a number, alphabetize the reference as though the number were spelled out. To cite a source with no author or no date in APA style, it is important that you know the basic information such as the title of the work, publisher if it is a book reference or volume and page details if it is a journal reference, and/or URL (uniform resource locator). The templates and examples for in-text citation and reference list entry of a book with no author and a book with no date are given below. Book with no author In-text citation template and example: Books with no author in general, but not always, are given as parenthetical citations. If you reference an article from a news source (e.g., CNN, NBC, Washington Post) or a site that may experience continuous updates, you would then need to include a retrieval date. New in 7th edition: You must include the site name in your citation, unless the site name is the same as the corporate author. For example, a citation of a CDC report would not include the site name. When possible, include the year, month, and date in references. If the month and date are not available, use the year of publication. Additionally, APA 7th edition no longer requires the use of "Retrieved from" before URLs or DOIs; special exceptions, however, are made for resources that are unarchived. Including the retrieval date for these sources indicates to readers that the version of the work they retrieve may be different than what was originally used. Please note: the following contains a list of the most commonly cited electronic sources. For a complete list of how to cite electronic sources, please refer to the 7th edition of the APA Publication Manual. URL Wikipedia Article APA 7 treats Wikipedia articles as special instances of entries in reference works. Thus, there are a few differences between reference entries for pages on Wikipedia and those for generic webpages. Title of article. (Year, Month Date). In Wikipedia. URL of archived version of page Wikipedia articles often update frequently. For this reason, the date refers to the date that the cited version of the page was published. Note also that the manual recommends linking to the archived version of the page, rather than the current version of the page on the site, since the latter changes over time. Archiving the version of the page you want to cite is done by clicking "View History," then clicking the date/timestamp of the version you'd like. Online Scholarly Journal Article: Citing online materials can potentially change URLs. APA recommends providing a Digital Object Identifier (DOI), when it is available, as opposed to the URL. DOIs are an attempt to provide stable, long-lasting links for online articles. They are unique to their documents and consist of a long alphanumeric code. Many—but not all—publishers will provide an article's DOI on the first page of the document. Note also that some online bibliographies provide an article's DOI but may "hide" the code under a button which may read "Available" or may be an abbreviation of a vendor's name like "CrossRef" or "PubMed." This button will usually lead the user to the full article which will include the DOI. Find DOIs from print publications or ones that go to dead links with doi.org's "Resolve a DOI" function, available on the site's home page. If an online scholarly article has no DOI and is published on a database, do not include a URL or any database information. The only exception is for databases that publish articles that are in limited circulation (like ERIC) or that are only available on that particular database (like UpToDate). Note that retrieval dates are required for unarchived sources that are likely, or intended, to change over time. Abstract APA 7th edition does not provide guidance on how to cite abstracts. However, if you only use information from the abstract but the full text of the article is also available, we advise you to add "[Abstract]" after the article or source name. If the full text is not available, you may use an abstract that is available through an abstracts database as a secondary source. Online News Article Note: The format for this type of source depends on whether your source comes from a site with an associated newspaper. If the interview transcript is published in an online periodical, like a magazine, cite the interview the same way you would cite the medium where it is published, as shown below: If it is an audio file or transcript published in a database, credit the interviewee as the author and use the following model: Online Lecture Notes and Presentation Slides When citing online lecture notes, be sure to provide the file format in brackets after the lecture title (e.g. PowerPoint slides, Word document). How you cite a website in APA with no author is to use the article's title instead. Although it is acceptable to include information from sources with no author listed in your APA website citation, make sure it at least comes from a reliable website, such as a government entity, university, or reputable organization. How To Reference a Website With No Author Name Listed - APA 7th Edition Online citations in APA style have four different components: the author, date, title, publisher, and URL. Many times, especially in local newspapers, articles are printed as staff articles or without any author's name listed. If you do not know the author's name or the article's date, you can still cite a webpage in your APA 7 style references list by using the title of the article. Tips for Evaluating Online Articles It doesn't matter if you're writing a short essay or a long research paper; you can use online articles with no authors as sources. Just be sure to include reliable primary and secondary sources to back up your research. Therefore, your research should focus on finding authoritative sources. One way to establish authority is to inspect the author's name and professional background. For example, if an article describes how to treat a medical condition, you would undoubtedly want to know the author's credentials before following any advice. Although you may find articles with no author listed on reputable sites, it is better to establish the authority of your article by using sources written by established authors. If you find a random article that seems "formula" created with no listed author or references, bypass that source and choose a better one for your APA format paper. No Author, No Problem When it comes to creating a website citation in your reference list or in-text without an author, it's not as hard as you think. An example of a no author citation looks like: Title of the article. (Year, Month Day). Website. URL (no period after the URL) When you have a website in APA 7 with no author, you use the title, date, publisher, and URL. There is no period after the URL in the citation. Additionally, a website title is in italics. To cite a website in APA format, you need the author, date, title of the article, name of website, and URL. It may state last updated, last modified or last reviewed. If there is no date available then use (n.d.) for no date. Websites have become popular sources of information for students and researchers by considering the rule of the APA 7th edition format. In this case, websites carry tons of data, including texts, images, and videos that writers can use as evidence. According to academic writing standards, when students gather evidence from websites, they must cite it appropriately not only in the References page but also within in-text citations by considering their essays and research papers. However, some sites lack essential credentials for citation entries for the APA format. In summary, when citing a website with no author in APA 7, a student should write the name of the site and the URL. Moreover, when a site lacks a publication date, scholars should use n.d., and, when there is no known author, they should use a shortened version of the title and enclose it within quotation marks. In turn, if there is no title, authors should use a short description of the article and enclose it within square brackets. The Internet is a platform that allows individuals and organizations to display texts, images, and videos, all of which are popularly known as content. Basically, the time when it is published allows readers to know how old the content is and whether it passes the test of being the most recent information. In academic writing, instructors insist on using the most recent information as the basis of a writer's argument. Therefore, if web-based content lacks a date of publication, students should substitute the year with the initials n.d., which indicates "no date." An example of such a website citation in APA 7 is as follows: Culbertson, H. (n.d.). Conflict management strategies and styles. Southern Nazarene University. Retrieved from culbert/conflict.htm The APA in-text citation for a website without a date of publication should be: Culbertson (n.d.) states that conflict management is an essential skill of effective leadership. Sometimes, web-based content may lack an author, whether an individual or corporation. For example, when there is no individual author, a writer uses the name of the organization instead. By considering the APA citation, when both are missing, students should use the title of the content - book, article, or document - as the author. How to Cite a Website Without a Title of an Article When students cite web-based content as a source of evidence in APA 7, they should use a description of the content - book or article - as the title in italics. The scheme of an APA reference citation for a website with no title of an article should be: Author's Last Name, First and Middle Names' initials. (Publication Year, Month Day). Description of document. Website Title. Retrieved from URL. An example is as follows: Worland, J. (2015, July 27). Flood risk in the US. Times. Retrieved from The APA in-text citation should be: The US is experiencing severe weather in recent times, with floods estimated to have cost the country billions in infrastructural damage (Worland, 2015), or In a Times news article, Worland (2015) calls on the federal government... When a writer uses web-based content with no known author or publication date in APA 7, they should use the format described above for content without a known author and content without a publication date. Gardner Senate. Retrieved from Note: The above example assumes the content had no date of publication. The in-text citation should be: A lack of bipartisanship in the Senate threatens to derail Obamacare Tax ("Legislation," n.d.), or The article "Legislation" (n.d.) provides the dynamics surrounding the passage of Obamacare Tax. When writing academic texts, students and researchers rely on web-based content to back up their arguments. Basically, this content includes articles, books, and videos, among others. Hence, some essential tips that students and researchers must master include: Put the title of the article in italics. Indicate the website name (without italics). Put a period after the website name, followed by the phrase "Retrieved from" and URL. When there is no date of publication, use the initials "n.d." If there is no known author, use the title of the online article as the author in italics. If there is no title, use a short description of the article as the title in italics.
